NOT DEFINITIVE

In the civil case of First Instance registered under No. r.g. 12219/2018 brought by:

MAGNI REAL ESTATE S.r.l. (formerly C.M.C. srl; C.F. 01883110361), represented by lawyers BERGOMI GIULIO (omissis) and REBECCHI PIER GIORGIO (omissis) MAGNI TELESCOPIC HANDLERS S.r.l. (C.F. 03353620366), represented by lawyers BERGOMI GIULIO (omissis) and REBECCHI PIER GIORGIO (omissis)

PLAINTIF

v.

MANITOU ITALIA SRL (C.F. 00173970369), represented by lawyers CAVANI GIOVANNI and BARALDI DAVIDE (omissis), MIRTO CINZIA (omissis)

DEFENDANT

The Court of First Instance, NOT definitively ruling, all other requests and objections

disregarded or absorbed, decides as follows:

- <u>DECLARE</u> admissible and relevant the description operations performed between 25 August and 5 September 2018 (Proceeding No. G.R. 9391/2018).
- 2. **<u>DISMISSES</u>** the counterclaim for a declaration of invalidity of the patents at issue (Italian patent No 1417457 and European patent No 2981496, amended version).
- 3. <u>ADMITS</u> the application for a declaration of patent infringement, in the manner and to the extent set out in the grounds of judgements and, accordingly,
- 4. **INHIBITS** to Manitou Italia s.r.l. the production, the offer for sale and the sale of counterfeit rotary telehandlers, marked with the initials MRT-X 2470 Privilege Plus (possibly, with the addition of the initials ST 3AS1), MRT 2470 Privilege (possibly, with the addition of the initials ST4S1), MRT-X 3050 Privilege Plus (possibly, with the addition of the initials ST4S1), MRT 3050 Privilege (possibly, with the addition of the initials ST4S1) or with other initials; as well as the same machines also under different trade names.
- 5. FIXES the sum of EUR 70,000.00 against Manitou Italia srl and in favour of Magni Real Estate srl (formerly CMC srl) and Magni Telescopic Handlers srl, for each breach or noncompliance subsequently ascertained and for each delay in the execution of the judgment.
- 6. **<u>DECLARE</u>** that the claim of unfair competition is absorbed.
- 7. **<u>DENIES</u>** the request for publication of the judgment.
- 8. **PROCEEDS** by separate order to remand the case for the continuation of the pre-trial proceedings.
- 9. **<u>RESERVES</u>** further action upon final judgment.
